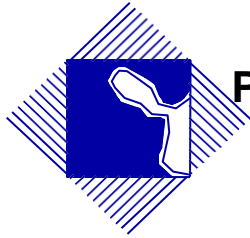


Participation During Coastal Clean-ups.




