## The dates of the Board Meetings have been rescheduled for the following reasons:

**January 12, 2024** - On December 28, 2023, PCEO and OIC Chairman Atty. Felix S. Racadio requested to move the scheduled meeting to January 10, 2024 due another appointment on January 12, 2024. The same has been approved by the majority of the PPMC Board Members.

**February 9, 2024**- declared as a Special Non-Working Holiday by virtue of Proclamation No. 453 to celebrate Chinese New Year. The meeting was supposed to be held in Sulvec/Vigan City on February 15-16, 2024 due to the proposed venue's available dates, however, the Board agreed on February 6, 2024 to hold said meeting at the PPMC Board Room.

March 8, 2024 - the meeting was rescheduled to March 13, 2024 to coincide with the scheduled ocular visit to Harbor Centre Port Terminal, Inc. in Subic.
