2.2	Are we allowed to inspect the site at any time?	Bidders may inspect the site from Monday to Friday, from 8:00 AM to 5:00 PM.
2.3	On page 30 of the Specifications, some of the words are in red font color. What does it mean?	The words in red font color were not just recolored in black. The specifications remain the same.
2.4	Why is the gazebo on a side footing?	Cantilever footings are allowed in construction. There is no prohibition on the use of the cantilever footing. Further, there is limited space for the foundation footing since the working space will pertain only to the existing area of the gazebo to be rehabilitated.
