Can we submit a certification issued by the manufacturer indicating that our vehicle brand is in existence for more than ten years in the Philippines?	The technical specifications provides that the vehicle brand must have good quality track record and must have been commercially sold and distributed in the Philippines for at least ten years from the date of the Invitation to Bid. If the manufacturer can provide such certification, it is acceptable.
How much is the bidding documents?	The amount of bidding documents is Five Thousand Pesos (Php 5,000.00), non-refundable
